Galloway's Seoul is a five day summer camp for young people in P7-S6 (in school year 2027/28). The camp follows the structure and format of World Youth Day which will be taking place around the same time in Seoul, South Korea. Over the five days, young people will take part in times of:

- Catechesis & Mass – led by Bishop Frank Dougan and Fr Kevin Rennie (Diocesan Youth Chaplain)
- Prayer & Discussion – reflecting on the themes and what they've learnt in the teaching.
- Outdoor activities – including canoeing, paddleboarding, tree climbing and archery tag.
- Time with friends – joining young people from across Ayrshire and Dumfries & Galloway, they'll have the chance to spend time with friends and make new friends.

The event is run by the RC Diocese of Galloway Youth Office which organises and runs events for Youth and Young Adults to encourage them to meet with young people to make friends, grow in their faith and knowledge of God, and most importantly – to have fun!
